

Terms and Conditions – Corporate Tents

These Terms and Conditions ("T&Cs") govern the agreement between JLL Triathlon and the corporate entity purchasing a corporate package for the 2025 triathlon event. By purchasing a package, the corporate entity agrees to comply with the following terms:

1. Packages and Pricing

JLL Triathlon offers the following partnership packages:

Package 1 – Tented Village – Large Tent

- **Tent Dimensions:** 6m x 6m x 2.4m (D x W x H), with three sides and an open front.
- **Inclusions:** Two trestle tables and five chairs. Additional tables (£10 each) and chairs (£5 each) may be ordered.
- **Catering Packages:**
- **Location:** Grass spectators' area in the main tented village.
- **Branding & Digital Adverts:** Full-colour advert on the digital results screen displayed intermittently throughout the day. Tent branding permitted within reasonable limits.
- **Cost:** £1,750 + VAT.

Package 2 – The Mound (Run Course) – Medium Tent

- **Tent Dimensions:** 6m x 3m x 2.4m (D x W x H), with three sides and an open front.
- **Inclusions:** Two trestle tables and five chairs. Additional tables (£10 each) and chairs (£5 each) may be ordered.
- **Location:** Grass mound parallel to the run course.
- **Branding & Digital Adverts:** Full-colour advert on the digital results screen displayed intermittently throughout the day. Tent branding permitted within reasonable limits.
- **Cost:** £1,250 + VAT.

Package 3 – The Mound (Run Course) – Small Tent

- **Tent Dimensions:** 3m x 3m x 2.4m (D x W x H), with three sides and an open front.
- **Inclusions:** One trestle table and four chairs. Additional tables (£10 each) and chairs (£5 each) may be ordered.
- **Location:** Grass mound parallel to the run course.
- **Branding & Digital Adverts:** Full-colour advert on the digital results screen displayed intermittently throughout the day. Tent branding permitted within reasonable limits.
- **Cost:** £900 + VAT.

2. Catering Packages

Dorney Lake will offer all corporate package holders the opportunity to pre-order food and drinks for delivery to their tent on the event day. Catering menus will be shared at a later date.

Completed forms must be submitted directly to Dorney Lake by the deadline shared by JLL Triathlon. Late submissions may not be accommodated.

All catering invoices will be issued by Dorney Lake and need to be paid for before the event.

3. Event Operations and Guidelines

To ensure smooth event operations, the corporate entity agrees to adhere to all event guidelines, including but not limited to:

- **Set-Up and Breakdown Times:**
The corporate entity must set up their allocated space within the designated timeframe provided by JLL Triathlon. Breakdown must also occur within the specified times.
- **Vehicle Access and Parking:**
All vehicles must be parked up by the times specified by JLL Triathlon. Details regarding vehicle access will be provided in advance of the event.
- **Compliance with Directions:**
The corporate entity must follow all directions given by event staff regarding safety, site layout, and operational protocols.
- **Restrictions on Equipment and Catering:**
No personal barbecues, independent caterers, or gazebos are permitted by the venue.

Failure to comply with these guidelines may result in removal from the event, or additional charges.

4. Branding and Advertising

The corporate entity is responsible for any branding of the tent, provided it does not disrupt neighbouring setups or violate event guidelines. JLL Triathlon reserves the right to request removal or adjustment of any branding deemed inappropriate or intrusive.

The digital advert provided by the corporate entity must meet specifications provided by JLL Triathlon and be submitted by **Friday 13th June**. Late submissions may result in the omission of the advert, without compensation.

5. Cancellation Policy

- **Any cancellations made after the 9th May:** No refund will be provided.

JLL Triathlon will not be held liable for any failure by corporate entity to use the package benefits (e.g. absence at the event, failure to submit branding materials).

6. Force Majeure

In the event of unforeseen circumstances beyond JLL Triathlon control (e.g., extreme weather, government restrictions, or emergencies) that result in the postponement or cancellation of the event, JLL Triathlon will endeavour to reschedule. Refunds will not be provided in such cases, but the corporate entity's booking will be transferred to the rescheduled event.

7. Amendments

JLL Triathlon reserves the right to amend these T&Cs at its sole discretion. Any changes will be communicated to the corporate entity in a timely manner.

8. Acceptance of Terms

By completing the corporate tent package confirmation form, the corporate entity confirms their acceptance of these T&Cs.
